PARTINGTON'S HOLIDAY MAKER PARK RULES 2026

1 Holiday Homes and Pitches

- 1.1 No holiday home shall be used for sleeping more than the permitted number of people allowed in your holiday accommodation.
- 1.2 Holiday makers must not remove wheels from holiday homes.
- 1.3 No fires or chimineas may be lit outside a holiday home in any circumstances whatsoever. Only British Standard approved barbecues and patio heaters may be used, but not within 2 meters of any holiday home and not on grassed areas. No disposable barbecues are allowed.
- 1.4 Clothes lines and rotary driers must not be used.
- 1.5 Rubbish must be placed in receptacles provided and not left outside the holiday home.
- 1.6 Dogs must be registered as part of the booking process. 2 dogs are permitted per holiday home. Dogs must be kept on a short lead at all times. Outdoor dog pens/fencing are not permitted. Dog fouling is the dog Owner's responsibility and must be removed immediately. Failure to do so will result in a £100 fine. Excessively noisy and aggressive dogs, and dogs determined by the Banned Dogs Act are not allowed on the premises. Dogs are not to be left unattended at any time outside holiday homes. We reserve the right to invoke section 7 in response to intimidating or aggressive behaviour from a dog.
- 1.7 Dogs are not permitted in the children's play area.
- 1.8 Drones are not permitted on the Park.
- 1.9 Recycling: please use the dedicated recycling areas on the park.
- 1.10 Do not flush wet wipes, toiletries, and sanitary products down the toilet. This will cause drain blockages, and in some cases, sewage to back up into your holiday home.
- 1.11 Fireworks are not permitted on the Park.

2 Behavioural Standards

- 2.1 Upon entering the Park, it is your responsibility to ensure that you, and people who occupy the holiday home as your guests (including children), adopt the following standards of behaviour:
 - 2.1.1 Act in a courteous and considerate manner towards staff and Partington's customers. Discriminating, threatening and intimidating behaviours and acts of violence of any kind will not be tolerated.
 - 2.1.2 Supervise children so that they are not a nuisance or danger to themselves or others and supervise them at all times whilst in the vicinity of any water or ponds should the park you're staying at have these features.
 - 2.1.3 Please note groups of children under 18 must not be left unsupervised in your Holiday accommodation at any time. You are responsible for ensuring the behavioural standards of all your party and any guests meet the behavioural standards outlined in section 2 of the Holiday Maker Park Rules. Failure to comply with these rules may result in you being asked to leave the Park and the occupation of your holiday accommodation being terminated forfeiting the amount paid for your booking.
 - 2.1.4 Do not commit any criminal offence on the Park or to use the holiday home for the furtherance of any criminal activity.
 - 2.1.5 Do not commit any acts of vandalism or nuisance.
 - 2.1.6 Do not keep or carry any firearm or any other weapon (including pellet guns, catapults, BB guns, knives and sharp objects etc) on the Park.
 - 2.1.7 Do not use any unlawful drugs.
 - 2.1.8 Do not smoke and/or vape inside any Park facility, nor any holiday accommodation.
 - 2.1.9 Do not create any noise or disturbance, particularly between the hours of 11.30pm and 8.00am.
 - 2.1.10 Any trade or business of any kind, on the Park, is not permitted.
 - 2.1.11 No parties of youths are allowed on the Park (under 21s).
 - 2.1.12 Do not play ball games between holiday homes.
 - 2.1.13 Do not bring food into any of the Park facilities and venues.
 - 2.1.14 If, in the opinion of the Park Manager, these standards of behaviour are not adhered to, then further action will be taken, with the possibility of Rule 7 being enforced. Statements in relation to the Park, it's Proprietors or staff which are untrue, threatening, defamatory, obscene, unlawful or which could otherwise reasonably cause distress, must not be published on social, or any other form of media.

3 Drivers and Vehicles

- 3.1 All vehicles must observe a 10 m.p.h. speed limit and make use of the car parking spaces provided.
- 3.2 No vehicles are allowed on the grass. Any damage caused by driving or parking on the grass will be charged to the vehicle owner.
- 3.3 All drivers must hold a current full license and insurance, and comply with the Road Traffic Act at all times, including driving under the influence of drugs or alcohol.
- 3.4 The repair, maintenance, dismantling, advertising for sale or restoring of motor cars, motorcycles, watercrafts, trailers or boats on the pitch or Park is strictly prohibited.
- 3.5 The use of 'go-peds', segways, powered scooters, powered skateboards, quad bikes, motorcross bikes and vehicles unfit for the public highway are strictly prohibited on the Park.
- 3.6 No sign-written, commercial, large goods vehicles (LGV), motorhomes/campervans or trailers are permitted to be parked outside a holiday home or Park facilities. This includes vehicles with no passenger seats behind the driver. 1 car is permitted per holiday home (accommodation dependent). The maximum vehicle height permitted is 1.9 meters.
- 3.7 Drivers must observe all parking restrictions. Disabled spaces at the facilities are for disabled badge holders only. Drivers must park considerably.
- 3.8 All drivers must observe the one-way system.
- 3.9 Do not charge electric vehicles from your holiday home. This is a fire risk. Only use official charging points in the area. Please ask Reception for details.

4 Liability

- 4.1 The Proprietors will accept no responsibility for any loss, damage or expense of any person using the Park, except for death or personal injury arising from our negligence.
- 4.2 The Company uses its best endeavours to ensure the availability of all amenities advertised but shall not be liable in respect of their non-availability.
- 4.3 We reserve the right to enter the holiday home for maintenance purposes, or in special circumstances and emergencies.

5 Utilities and Services

- 5.1 Wi-Fi internet services – Owners and users of the service must read and abide by the terms and conditions found at <https://www.partingtons.com/wifi-policy/>.
- 5.2 Nobody under the age of 16 is permitted to use the gym facilities. Any other persons using these, do so at their own risk.*
- 5.3 Nobody under the age of 8 is permitted to use a hot tub and sauna within our hire fleet accommodation. Persons 8-16 must be supervised by an adult.*
- 5.4 Nobody under the age of 18 is permitted to use a hot tub, steam room and sauna within the swimming pool complexes.*
- 5.5 Before you stay in any of our accommodation you will be required to provide a pre-authorised from a bank card. All security agreements will be due within 7 days of arrival, the amount will be preauthorised on your card (the balance will not be taken from your account at this time) and only claimed if there is evidence of anti-social behaviour or damage during your stay. This additional protection is in place to maintain the high standards of Partington's Holiday Parks.

6 Charges

- 6.1 In the instance of a lost key, £20 will be charged for a replacement.
- 6.2 If the Park are in possession of any lost property, that is requested to be posted back, cost of postage will apply and the Company is not responsible for any lost items.

7 Termination of Occupation

- 7.1 The Proprietors reserve the right to terminate your occupation of a holiday home on the Park upon breach of any of the foregoing regulations, or for any reason. Thereafter, you forfeit the amount paid in respect of your holiday.
